

# New LSTA Coordinator Orientation: Grants to States (G2S) Program

## **Common Acronyms and Terms**

## Statutory

MLSA: Museum and Library Services Act, the broader IMLS statute that encompasses LSTA

**LSTA:** Library Services and Technology Act, as amended, a subchapter of the authorizing legislation for IMLS (see 20 U.S.C. § 9101 et seq., particularly § 9121 et seq.) Shorthand in the field for Grants to States funds, though LSTA also encompasses IMLS discretionary programs.

**SLAA:** State Library Administrative Agency

#### Grant Administration

**SPR:** State Program Report, the online system developed by IMLS for the annual Grants to States reporting. Available at <a href="https://imls-spr.imls.gov/Login">https://imls-spr.imls.gov/Login</a>

eGMS: electronic Grants Management System for IMLS

Reach: messaging system used in eGMS

Login.gov: a secure sign in service needed to access eGMS Reach since January 2023

**UEI:** Unique Entity ID, the authoritative identifier assigned by SAM to uniquely identify business entities, which replaced the DUNS number in 2022. It is a 12-character alphanumeric value.

SAM.gov: System for Award Management website, where a grantee registers to do business with the US government

**EIN:** Employer Identification Number

FAIN: Federal Award Identification Number, a unique number assigned to your grant by IMLS, e.g., LS-246139-OLS-24

TIN: Taxpayer Identification Number used by the IRS

**ACO:** Authorized Certifying Official for the grant award; in most cases it will be the State Librarian, but it can also be the administrator that the state librarian reports to.

**CFR:** Code of Federal Regulations. IMLS adopts the OMB government-wide grant regulations in 2 C.F.R. part 200 (Uniform Guidance)

FFATA: Federal Funding Accountability and Transparency Act

FSRS.gov: FFATA State Reporting System, used to enter information on subrecipients who received grants of \$30,000 or more

## **IMLS Financial Requirements**

**Match:** The amount of money (34% of the program budget) our LSTA legislation requires a state library to contribute toward the grant program using non-Federal funds.

**MOE:** Maintenance of Effort (see 20 U.S.C. § 9133 (c)) Statutory requirement for States to maintain their financial contributions to the Grants to States program at not less than the amount of the average contributions over three fiscal years. Represents State funds for library programs consistent with the Purposes of LSTA. When a State does not meet its MOE in a given reporting year, its next allotment is reduced by the same percentage as the missed MOE. An MOE waiver process allows the SLAA to make a case for missed MOE.

### Pandemic Stimulus Funds

CARES Act: Coronavirus Aid, Relief, and Economic Security Act of 2020, one-time stimulus funding for pandemic response

ARPA: American Rescue Plan Act of 2021, a one-time stimulus funding for pandemic response

- "SPR Reporting System User Documentation SLAAView"
  - o Guides users through the SPR system, with screenshots and a glossary

#### Updating SLAA Contacts in the SPR

IMLS maintains 4-5 contacts per state (Chief Officer, Authorized Certifying Official – if different than Chief, LSTA Coordinator, Library Development, and Fiscal Officer). Every time a state has a contact change you must take the following steps and notify IMLS:

- Log into the SPR system: https://imls-spr.imls.gov/Login
- Use the menu navigation to go to Account Management > State Info
- Make any appropriate adjustments to the listed contacts. To maintain uniformity, please provide phone numbers in the XXX-XXXX format.
- Click the orange Update button at the bottom of the window.

#### Adding Users to the SPR

Contact your Program Officer to update or add users to the SPR system with the following levels of access:

- LSTA Coordinator (up to 2 perstate)
- Authorized Certifying Official ACO (1 per state, to match certifications on file with IMLS)
- Financial Manager/Fiscal Officer and 2 Other Fiscal Officers (optional). You need to request SPR-level access for any Fiscal Officers. They can also be added to the eGMS system and authorized to make drawdowns.
- SLAA Project Data Entry (unlimited number per state). Role allows someone to add, view or edit all projects, but they cannot validate, certify, or change state goals. It may be a useful role for additional state library consultants/evaluators.

The LSTA Coordinator and ACO accounts have permission to manage **subrecipient user accounts** in the system affiliated with a single institution. These two roles may establish user accounts as well as update lost/forgotten passwords for subrecipients.

- Log into the SPR system: https://imls-spr.imls.gov/Login
- Use the menu navigation to go to Account Management > Subrecipient Access
- Click Add User, and enter contact information (email address will be used to log in)
- Enter and confirm password
- Select assigned subrecipient (affiliated institution)
- Select Save User
- NOTE: to "delete" any existing SPR users, click their name, and under User Status, select "Inactive" then click Update User.

- SPR issues
- General feedback or questions for your program officer
