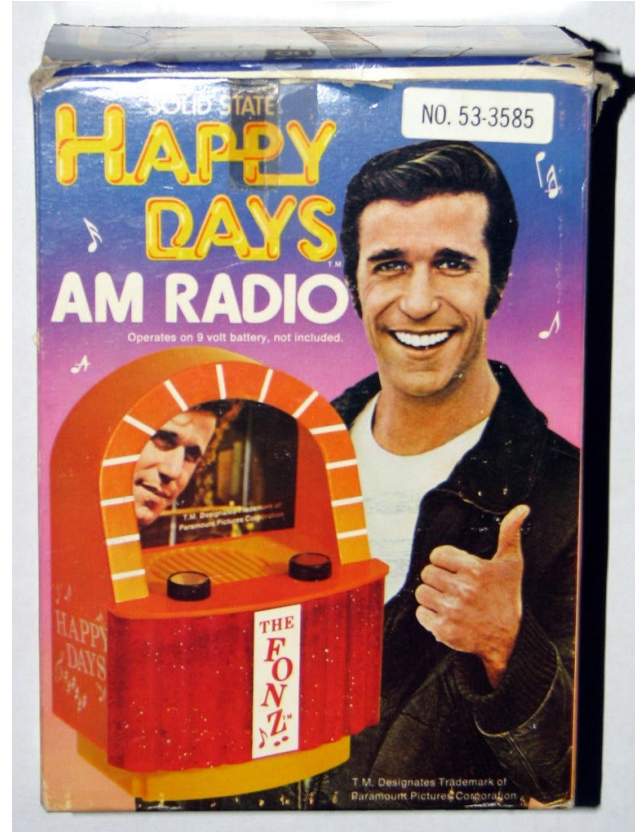

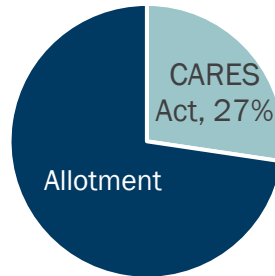

1,400 total

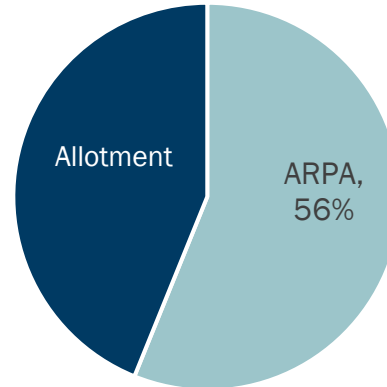


FY20 reported projects

2,902 total



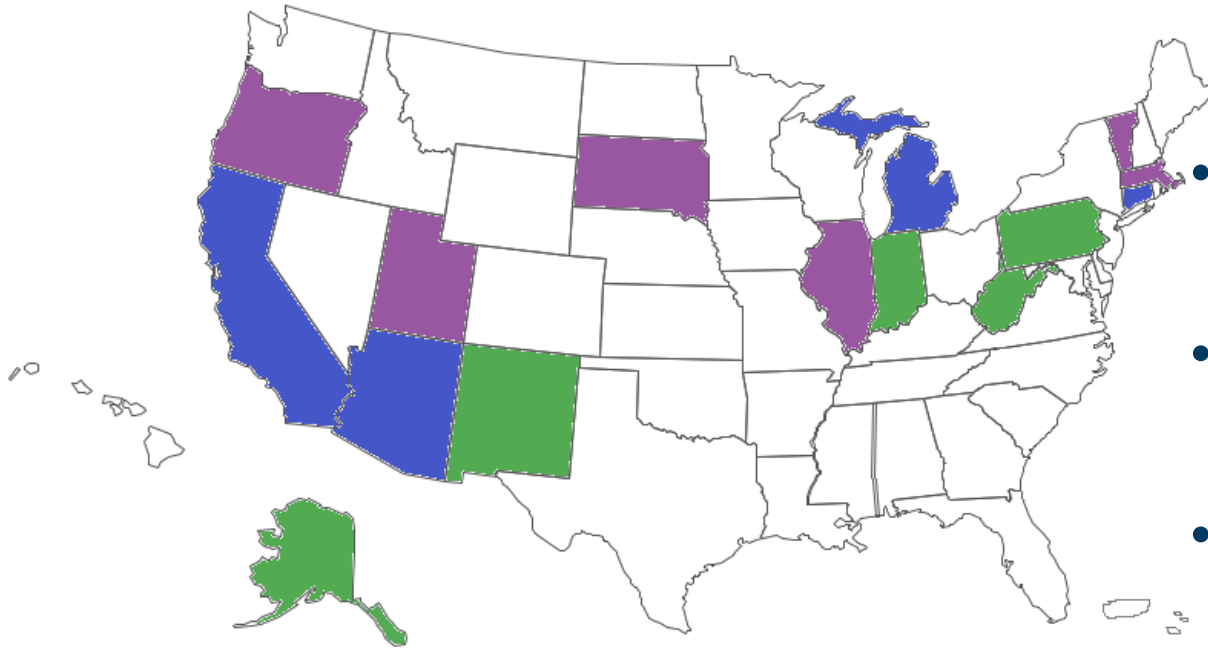
ARPA = \$178M more for SLAAs

**What is IMLS?**  
The Institute of Museum and Library Services (IMLS) is the primary source of federal support for the nation's libraries and museums. Our mission is to advance, support, and empower America's museums, libraries, and related organizations through grantmaking, research, and policy development. Our vision is a nation where individuals and communities have access to museums and libraries to learn from and be inspired by the trusted information, ideas, and stories they contain about our diverse natural and cultural heritage.

**What is the Grants to States Program?**  
The Grants to States program is the largest source of federal funding support for library services in the U.S. Through this program, IMLS provides financial assistance to develop library services throughout the States, U.S. Territories, and the Freely Associated States. IMLS funds support projects that, among other purposes, promote literacy and education; enhance and expand the services and resources provided by all types of libraries; enhance the skills of the current and future library workforce and leadership; develop public-private partnerships with other agencies and community-based organizations; and target library services to

## How to Get Paid Fast

- Submit your payment request through your eGMS Reach account using the Payments tab.
- *Resource:* Instructions are at <https://imls.gov/sites/default/files/2024-08/payment-request-instructions.pdf>.

### *Helpful Hints*

- **Submit no more than one payment request per week per award.**
- You can request payment as an advance or as a reimbursement, but not both for the same time period. Avoid overlapping payment periods.
- Know your award's end date. Don't request funds for a date that occurs after the end of your award's period of performance.
