

# State-Level Analysis of Public Library Service Adaptations in Response to the COVID-19 Pandemic



#### Introduction

Beginning in early 2020, public libraries in the United States faced the unprecedented challenges presented by the outbreak of the disease caused by the 2019 Novel Coronavirus (COVID-19) and the global pandemic declared by the World Health Organization. As detailed in Access to Public Library Services and Materials During the First Nine Months of the COVID-19 Pandemic (IMLS, 2023), libraries swiftly adapted to meet their communities' evolving needs.

During FY 2020, libraries implemented several significant changes in response to COVID-19. These included circulating physical materials outside the building (90 percent on average), increasing access to library materials without requiring in-person visits (70 percent on average), and expanding Wi-Fi access outside library buildings (71 percent on average). These service adaptations not only addressed pandemic-related needs but also accelerated the ongoing digital transformation within libraries, a trend that had been underway prior to COVID-19.

Despite the easing of restrictions and improved conditions in FY 2021, the pandemic continued to influence societal functions. The proportion of libraries that closed at any point during the year decreased from 90 percent in FY 2020 to 57 percent in FY 2021. However, social distancing and public gathering rules remained, necessitating continued modifications in library services to meet people's needs. Further insights on the impact of COVID-19 on libraries in FY 2021 can be found in the IMLS brief Changes in Public Library Services as COVID-19 Pandemic Continued through FY 2021 (IMLS, 2024).

This report builds on previous briefs, using statelevel data to explore the nuanced landscape of public libraries and their responses to COVID-19. It presents the percentages of libraries that answered "Yes" to six COVID-19 questions included in the Public Libraries Survey (PLS) for FY 2020 and FY 2021. By examining how libraries adapted their services during the pandemic, we gain deeper insights into how they sustained access to materials, ensuring communities continued to receive vital information and resources.

#### **Data and Methodology**

The PLS is a collaborative effort between the Institute of Museum and Library Services (IMLS) and the state library administrative agencies (SLAAs) of all 50 states, the District of Columbia, and five outlying territories. The analysis in this report focuses on the 9,021 public library systems (out of a total of 9,203)1 in the 50 states and the District of Columbia that met the Federal State Cooperative System (FSCS) definition of a public library.<sup>2</sup> This analysis dataset examines all public libraries reported in FY 2021, in contrast to the FY 2020 brief, which only analyzed 8,426 library systems whose fiscal years ended between May 2020 and December 2020—the time period representing the onset of COVID-19. This adjustment allows for a more comprehensive assessment of the pandemic's impact on public libraries, and the influence on library operations, services, and circulation.

This report presents findings both at the national and state levels. Each map figure below illustrates, by state, the percentage of "Yes" responses from library systems to the COVID-19 questions for either FY 2020 or FY 2021. The state profiles provide detailed findings for each state and by locales<sup>3</sup> within the state, for both fiscal years.

Additionally, both the report and profiles utilize median values for certain variables to mitigate the effect of outliers in the data (see **Appendix B** for details). Consequently, they may not sum correctly if disaggregated and will not match values found in publications that report by means and percentages, such as the PLS Benchmarking Tables or PLS reports prior to FY 2018.

Hawaii's public library data and data from the District of Columbia are reported under

one Administrative Entity (AE) each. When disaggregating AE variables by locale, this skews their data compared to other states because it is either 100 percent or 0 percent. Therefore, we do not specifically highlight them in the written summaries about each COVID indicator but do include them in the maps and profiles. Additionally, the outlying territories of American Samoa, Guam, the Northern Mariana Islands, and the U.S. Virgin Islands are included only in the profiles of this report. These library systems are each reported under one AE and will thus show 100 percent or 0 percent for many indicators, especially those disaggregated by locale.


To supplement the quantitative analysis in this report, the American Institutes for Research (AIR) conducted semi-structured interviews with staff from eight SLAAs in winter 2024. These half-hour interviews covered topics such as how libraries provided outside services like physical item circulation and Wi-Fi, how they implemented online registration, and other notable ways public libraries served their communities during the pandemic.

AIR also analyzed open-ended text responses shared by three State Data Coordinators from their state-level surveys. These responses highlighted adaptations, changes to services, and challenges experienced by individual libraries during COVID-19, providing library-level insights from all three states for FY 2020 and from two states in FY 2021.

## State-Level Differences in Access to Library Services and Materials

The pandemic significantly transformed the landscape of public library services, resulting in outlet closures, staff reallocations, the introduction of virtual reference services, and the provision of Wi-Fi access outside library buildings.

Library closures during FY 2020 and FY 2021 varied, with rates ranging from 100 percent in thirteen states including Georgia, Massachusetts, and Oklahoma, to less than 80 percent in Utah and New Jersey. Overall, the closure rate for libraries was approximately 94 percent, as detailed in **Table A2** of the appendix. **Figure 1** highlights




that many states had a substantial number of libraries closed to the public during either FY 2020 or FY 2021, reflecting the persistent challenges of the pandemic and efforts to curb its spread.

Interviews with SLAA staff revealed that some libraries, particularly smaller ones, faced periodic closures due to staff illness. Additionally, two states reported difficulties in reopening libraries because of staff shortages.

The open-ended responses from state-level surveys highlighted many ways libraries adapted to closures. A significant shift was seen in how libraries provided programming, with many transitioning to online delivery, offering virtual story times and book clubs. For example, libraries in New England launched a YouTube channel for virtual programming and used social media to share information about library resources. In the South, some libraries introduced a drop-off fax service where patrons could place fax pages in the book return. Staff would then send the documents on their behalf and notify patrons via email or phone once the submission was complete.

Outside circulation services allowed libraries to continue providing services to their patrons while buildings were physically closed and/ or had limited occupancy requirements in place. As **Figure 2** illustrates, several states had a large percentage of libraries offering outside circulation services either in FY 2020 or FY 2021. The percentage of libraries that provided outside circulation services ranged from 100 percent in five states including Wisconsin, Maryland, and Rhode Island, to 74 percent in New Mexico. The overall percentage of libraries offering outside circulation services was approximately 90 percent, as depicted in **Table A2** of the appendix. Multiple SLAA staff shared in interviews that these outside services became very popular with patrons during the pandemic for both safety and convenience reasons. SLAA staff from one western state explained that these services met a previously unrecognized need in their communities, allowing them to serve a broader audience. Many libraries continued to offer these services even as other in-person, in-building, services resumed. Only one state interviewed indicated that their libraries had largely moved away from offering outside access to physical materials.




Examples of these services, as seen in the openended responses on state-level surveys, included contactless curbside pickup, home deliveries of reading materials, and craft and literacy bags for patrons. Many library staff also mentioned the need to quarantine and sanitize materials picked up or returned through the book drop to mitigate the spread of COVID-19 and ensure safety for the next user.

Free, extended internet access remained an essential service that libraries provided to meet the needs of their patrons, with over 70 percent of libraries offering this service in FY 2020 or FY 2021. The extent to which libraries intentionally expanded outside Wi-Fi access during FY 2020 and FY 2021 varied, ranging from over 95 percent

in states like Virginia, Kentucky, and Oregon to less than 40 percent in Pennsylvania and California. Libraries cited the primary reasons for providing this enhanced service as better serving patron needs while physical closures or limited occupancy policies were in place. Many libraries reported adding free Wi-Fi access in their parking lots and creating outdoor seating areas to facilitate Wi-Fi use.

The percentage of libraries that increased this access across all states was approximately 71 percent, as depicted in appendix **Table A2**. **Figure 3** illustrates that most states had a moderate percentage of libraries that intentionally increased Wi-Fi outside their facilities in either FY 2020 or FY 2021.




Many of the SLAA staff interviewed reported creating maps on their websites to show where libraries offered free Wi-Fi, the hours it was available, and whether the building was also open to the public. In some cases, state library staff provided technical advice to libraries on how to position Wi-Fi access points to improve and extend outside connectivity. Public libraries in

several states also expanded internet service by acquiring Wi-Fi hotspot devices that patrons could check out.

Many libraries continued to offer, and in some cases added, online library card registration during the COVID-19 pandemic. Interviews with SLAA staff revealed that many public libraries across

several states used online registration to grant new patrons temporary access to both physical and electronic materials. Only one of the eight states interviewed indicated that online registration was only for electronic materials. Public libraries determined these online registration procedures at the local level, although a few SLAAs provided some "best practice" guidance; the overarching goal was to decrease barriers for patrons to use library resources.

As depicted in **Figure 4**, the range of libraries allowing patrons to register online for library cards while physical library buildings were closed varied from less than 55 percent in states like North Dakota and Tennessee to 100 percent in states like Maryland and Delaware. A detailed breakdown is provided in the appendix in **Table A2**. When reviewing the year-to-year comparison of online library card registration (**Table A3**) the data shows that libraries in 28 states began to discontinue this service in FY 2021.





The majority of public libraries provided reference services remotely by phone, email, or online chat, in many cases continuing to offer a service that was available before the pandemic. An example of this type of service was seen through online Book-A-Librarian appointments. The provision of virtual reference services via the Internet or telephone in libraries exhibited varying rates of implementation, from 100 percent in Maryland and Delaware, to less than 80 percent in states like Alaska, Idaho, and Kansas. The percentage of libraries that provided virtual reference services across all states was approximately 89 percent, as shown in **Table A2** in the appendix. **Figure 5** 

illustrates that at least 80 percent of libraries in most states offered virtual reference services in FY 2020, FY 2021, or both.

The practice of reassigning staff to work outside of their libraries varied significantly by state. In either FY 2020 or FY 2021, as illustrated in **Figure 6**, over 50 percent of libraries reassigned staff in states like California and Florida, compared to less than 2 percent in Michigan and Missouri. As depicted in **Table A2**, approximately 16 percent of libraries implemented staff reassignments outside their libraries across all states in either year.








As reported in the FY 2020 brief (IMLS, 2023), the practice of reassigning staff is primarily correlated with the governance structure of public libraries and is more prevalent among those situated within municipal or county governments. In response to the open-ended questions, libraries in the South indicated schedules and workloads were adapted to keep all employees paid and working during COVID-19, never fully shutting down services to the public. In the Pacific Northwest, staff in small rural libraries continued to work in the buildings while staff in the larger libraries were furloughed or laid off, with limited staff remaining onsite to answer phones and issue library cards. In New England, staff in some libraries mentioned working remotely to provide phone and email reference services to patrons.


A recurring theme from interviews with SLAA staff was the initiation of regular check-in meetings for library directors to share best practices during the pandemic. While the frequency of these meetings has decreased, several states have continued to hold them, recognizing the ongoing need for library staff to learn from each other and better serve their communities.

In a trend that has been observed since FY 2018 (IMLS, 2021), the median electronic circulation per person has continued to rise. The overall median electronic circulation per person increased to 0.73 in FY 2021, up from 0.48 in FY 2018. **Figure 7** and **Table A4** in the appendix show that the states with the highest median electronic circulation per person are South Dakota (1.80), Utah (2.02), and Washington (1.85).



While every state has seen increases in the median electronic circulation per person between FY 2018 and FY 2021, the range of this increase is broad. States like North Dakota and Nevada have experienced over a 300 percent change since

FY 2018, while a few states, such as Ohio and Washington, have seen more moderate increases (less than 30 percent) (**Figure 8** and **Table A4**).



#### **Summary and Future Research**

This report highlights the adaptations made by public libraries during COVID-19 in FY 2020 and FY 2021, showcasing the variations across states in response to the unique impacts of the pandemic in each region. Despite regional differences, a common theme emerges: public libraries played a crucial role in providing essential services to meet the diverse needs of their communities. Beyond the service modifications detailed in this report, some libraries were able to provide even greater services such as supplying additional free COVID-19 test kits, while others served as distribution sites for school lunches.

Future research opportunities will include a final review of the effects of COVID-19 on libraries during FY 2022 as the world continued its recovery. Comparing responses from FY 2018 through FY 2022 may provide valuable insights into how libraries are progressing in their recovery from the pandemic's impacts. FY 2022 is also the last year COVID-19 data elements are available on the PLS, making it a crucial point for analysis. In the long term, PLS data will be instrumental in assessing whether libraries experience lasting impacts on their finances, staffing, circulation, or other services following COVID-19.



## Appendix B. State Report and Profile Methodology and Caveats



#### **Use of Median Values**

Unlike previous years when mean values were used for figures and tables, the FY 2021 State Report and Profiles use median values for several sections to provide a better sense of what the "typical" value is. As a result, parts may not sum to totals and will not match values found in other publications that report by average, percentage, or count. Utilizing median values is best suited for data that contains outliers as it is not easily influenced by them. Mean, on the other hand, is better suited for more normally distributed data that does not have many or extreme outliers. Reporting by median values is better suited to certain PLS variables as it helps to counteract the variation seen in library systems (administrative entities) due to inherent differences such as population served, locale code, and number of outlets to name a few.

Additionally, **Figures 1–6** in this report and **Table A2** report percentages of libraries that reported Yes to the COVID-19 questions in either FY 2020 or 2021. The data in these maps and **Table A2** will not match the data in the profiles which is reported by individual fiscal year.

#### **Data Inclusion**

State profile data include active libraries that in FY 2021 met the definition of a public library developed by the Federal and State Cooperative System (FSCS). Libraries that did not meet this definition are excluded from analysis. See the FY 2021 PLS Data File Documentation for more information about the FSCS definition.

#### **State Comparisons**

Data comparisons between states should be made with caution due to differences in reporting periods and adherence to survey definitions. The definitions used by some states in collecting data from their public libraries may not be consistent with PLS definitions.

The District of Columbia, American Samoa, Guam, and Northern Mariana Islands, although not states, are included in these profiles. Special care should be used in comparing data for these profiles to those for states. Caution should also be used in comparing Hawaii's data to those of other states because all public library data in Hawaii are reported under one library system, the Hawaii State Public Library System.

#### **Missing Rates**

Several states had high missing rates for COVID-19 data used in the profiles. Use caution when comparing them to other states (**Table B1**).

**Population Size Served:** Based on the total unduplicated population of the legal service areas for each public library in the state that meets the FSCS definition.

**Public Library Systems:** Refers to the number of library systems (administrative entities) in a state.

**Public Library Outlets (Branches and Bookmobiles):** Refers to the number of public library outlets in a state. Outlets include central

**Librarians and Other Library Staff:** A subset of "Public Library Staff (FTE)," shown as rounded FTEs (Full-Time Equivalent).

**Total Operating Revenue per Person:** Calculated using the median sum of local government revenue, state government revenue, federal government revenue, and other operating revenue. Other operating revenue may include monetary gifts and donations received in the current year, interest, library fines, fees for library services, or grants.

#### **Total Operating Expenditures per Person:**

Calculated using the median sum of total staff expenditures, total collection expenditures, and other operating expenditures. Other operating expenditures may include expenses such as binding, supplies, repair or replacement of existing furnishings and equipment, and costs of computer hardware and software used to support library operations or to link to external networks, including the Internet.

**Circulation per Person:** Calculated using the median sum of physical item circulation and use of electronic material.

#### **COVID-19 Related Variables**

All six COVID-19 variables (items beginning with "C19" in the data files) had response options of "Yes" or "No." Missing values were assigned in states that did not provide responses to these questions.

#### Physically Closed Buildings to the Public:

Refers to the physical closure of any of the library's outlets to the public for any period of time due to COVID-19.

**Provided Outside Circulation Services:** Refers to provision of "outside" service for circulation of physical materials. This includes any contactless or minimal contact provision of circulation items (e.g., curbside, vestibule, or porch pickups, mail or drop-off delivery, drive-thru, etc.) during COVID-19.

#### **Intentionally Increased Outside Wi-Fi Access:**

Refers to intentional increase of Wi-Fi internet access for users outside the building during COVID-19.

#### **Allowed Online Library Card Registration:**

Refers to allowing users to register for library cards online without having to come to the library during COVID-19.

**Provided Virtual Reference Services:** Refers to reference services provided via the Internet or telephone (including e-mail, chat, text) when the building was physically closed to the public due

Staff Reassigned to Work Outside Library: Refers to whether AEs reassigned staff to work for other government agencies or nonprofit organizations instead of, or in addition to, their normal duties during the COVID-19 pandemic. This includes reassignments to other government agencies (e.g., to process unemployment claims), as well as other activities such as the use of library staff to distribute school lunches and other materials. Volunteering during work hours was counted, but volunteering during off hours was not.

#### **Locale Codes**

to COVID-19.

The urban-centric locale code system, developed by the U.S. Department of Education's National Center for Education Statistics (NCES), classifies geographic areas into four major locale types (i.e., city, suburb, town, rural) based on U.S. Census Bureau definitions.

- City: Territory inside an urban area with a population of 50,000 or more and inside a principal city;
- Suburb: Territory inside an urban area with a population of 50,000 or more and outside a principal city;
- Town: Territory inside an urban area with a population of 2,500 or more but less than 50,000; and
- Rural: Territory that does not lie within urbanized areas or urban clusters.

Locale codes were assigned to each library system using two methods: (1) the geographic location of the library system's physical address and (2) the modal locale code among central and branch libraries of that library system (i.e., excluding bookmobile and books-by-mail-only outlets). This brief uses the locale code assigned based on the second method: the modal locale code of the library system's associated stationary outlets. Additional details on how locale codes are used for the PLS can be found on pages 23–26 in the FY 2021 PLS Data File Documentation. The percentage of outlets by locale code may not sum to 100 due to rounding.














#### Physically Closed Buildings to the Public<sup>3</sup>




#### **Provided Outside Circulation Services**<sup>3</sup>




#### Intentionally Increased Outside Wi-Fi Access<sup>3</sup>




#### Allowed Online Library Card Registration<sup>3</sup>
